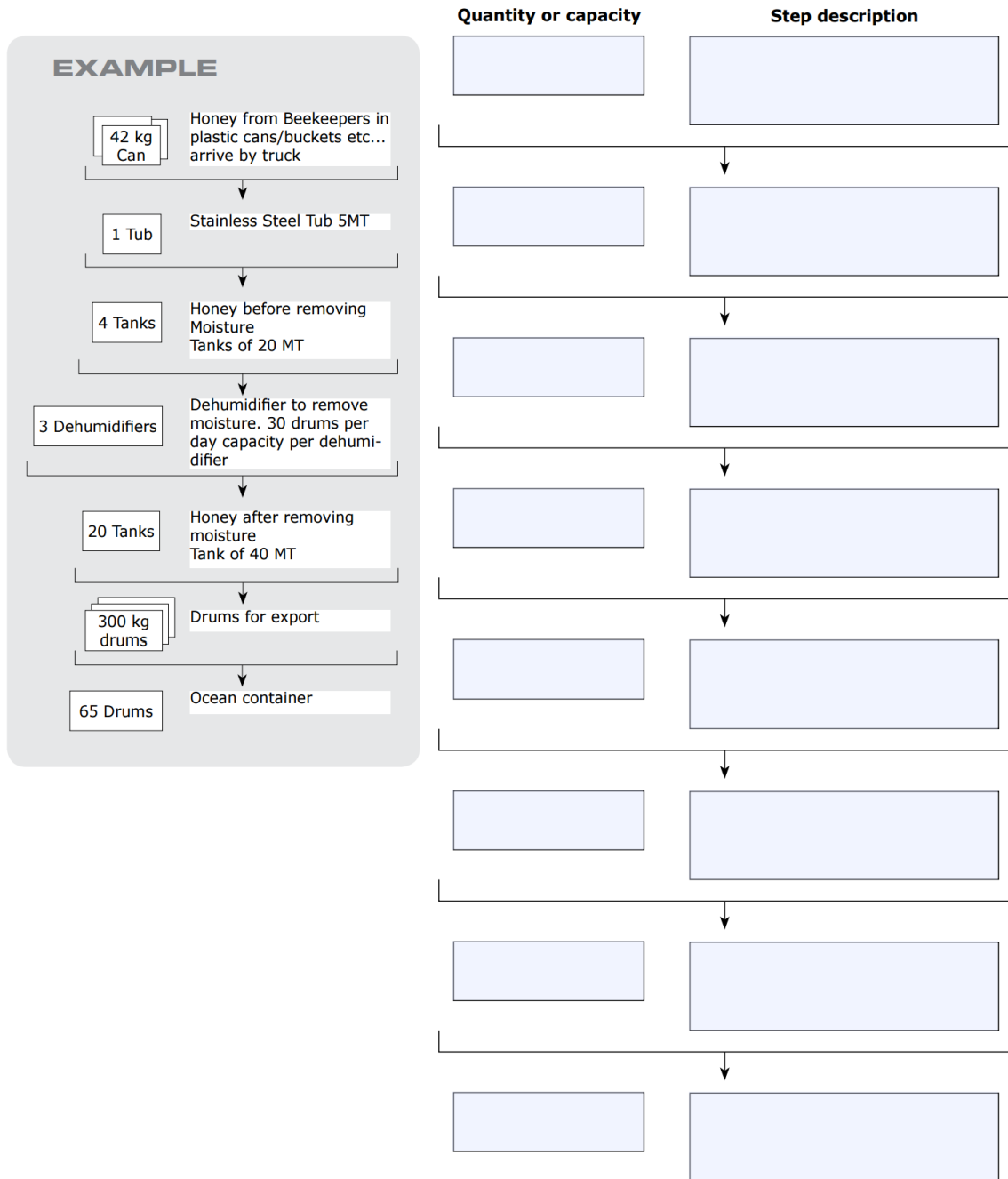

EXAMPLE 1

Markings or Record system

Each can is marked with beekeeper's name + date of extraction

Log book of deliveries by beekeepers to the sub Collector

- 1) date of reception
- 2) name of beekeeper
- 3) quantity for each beekeeper

Log book of deliveries by sub-Collectors to the Collector

- 1) date of reception
- 2) name of the sub-collector
- 3) list of the beekeepers in the lot and the quantity of honey for each beekeeper
- 4) lot code given :
Ex: SM-11-7 (Collector's name- year-month.)

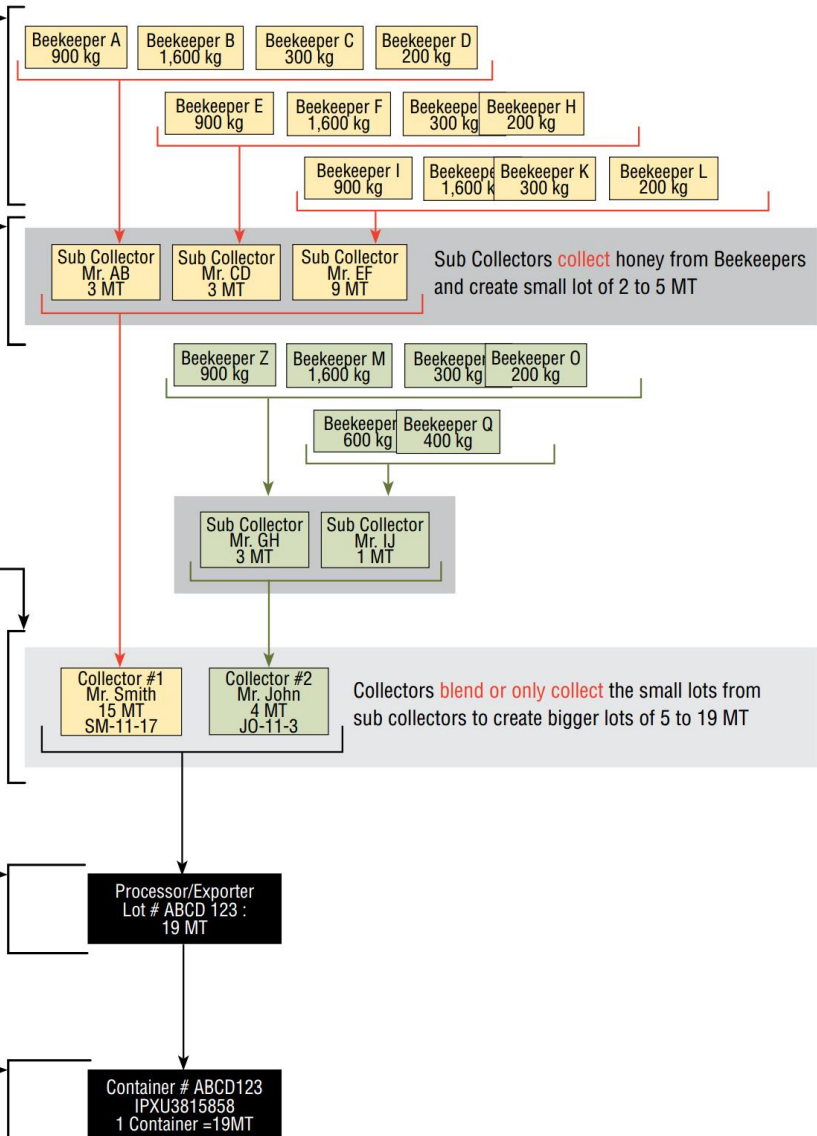

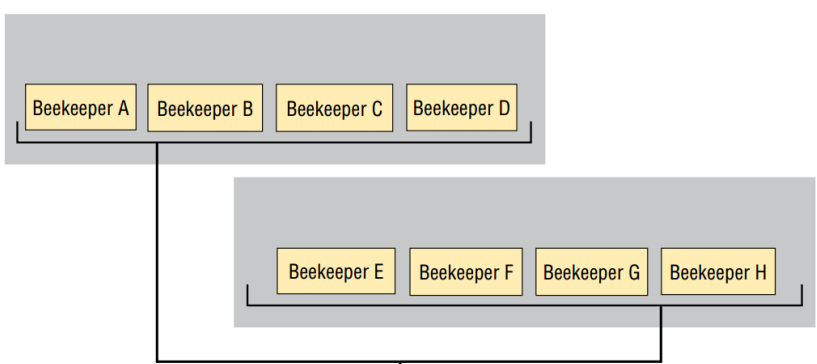

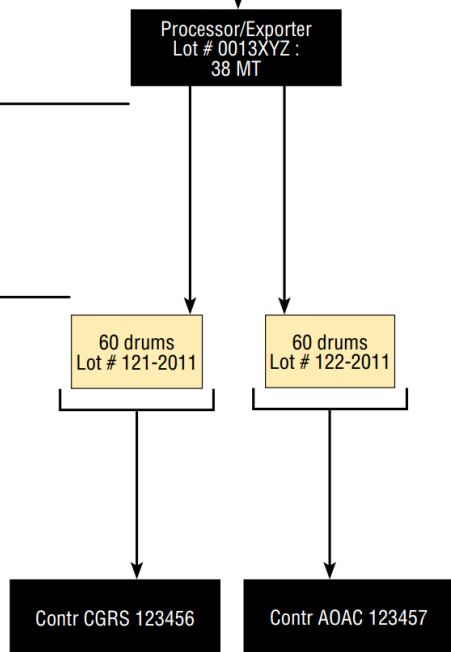
